Madam/Sir,



Many a time cooking is disrupted and the children get deprived. So you are supposed to ensure disbursement of Food Security Allowance to the children.

I am directed to request you to ask the Headmasters to open Bank Account of every child in the nearby banks for transfer of Food Security Allowance to the child's account. You should strictly adhere to the stipulations prescribed in the Odisha Mid-Day Meal rules for disbursement of Food Security Allowance. Odisha state food commission takes review of the progress of disbursement of food security allowance in regular basis. You are therefore advised to strictly monitor opening of bank account and disbursement of Food Security Allowance in time.


The report in this regard must be sent in the enclosed prescribed format by 15th Jan, 2018 for compliance to different quarters.
