

(Copy enclosed). • Every year the tender for engagement of Transport Contractor is being openly floated in the month of December and the contract is awarded by the District Administration w.e.f the 1st April of the next financial year for one year. The Ceiling price has been fixed (Rs.75 per quintal) by Govt. • The district procurement committee for ICDS, PDS etc is the procurement committee for Mid-Day Meal. • The agreement with Transport Contractor is being incorporated with strict provisions to deal with pilferage, misappropriation, diversion, quality change, weighment, insurance, security deposit, adulteration, acknowledgement, scrutiny, sample collection, SMS alert, FIR forfeiture, etc. • The transport of MDM rice was from FCI depot to school point without transit. • The authorized officer of Collector was with authenticated receipt of right quantity and quality of rice (FAQ rice). • The transport contractor was asked to carry the weighment equipment in the vehicles to every delivery point.
