**Sub: Allocation of foodgrains under National Programme of Mid-Day Meal Programme in Primary & Upper Primary schools (MDMS) for the 1<sup>st</sup> Quarter for the financial year 2014-15 (April to June, 2014).**

Madam/Sir,

With reference to the subject cited above, I am directed to intimate that the Govt. of India, MHRD have communicated allocation of foodgrains (Rice) for the 1<sup>st</sup> quarter (**April to June, 2014**) of 2014-15 in respect of the State under Mid-Day-Meal Programme for Primary & Upper Primary classes.

You may lift the stock of rice under Mid-Day Meal Programme in accordance with the quota allocated to your district from the FCI depots to which your district has been tagged, starting from 1<sup>st</sup> day of the month preceding the allocation quarter and upto 25<sup>th</sup> of the last month of the allocation quarter. The lifting and utilization figures in the prescribed proforma may be furnished to this office regularly in the 1<sup>st</sup> week of every succeeding month.

You are further, requested to start lifting the quota of foodgrains to be supplied by FCI which should be of best average quality. The allocated quota may be lifted without fail to ensure full utilization & send the lifting /utilization of foodgrains status in the enclosed format to the undersigned by 15<sup>th</sup> of April positively.


